1	BACKGROUND
2	Dr. Judith Ramaley will end her term on May 16, 2012, as the president of Winona State
3	University. In consideration of the presidential transition, Chancellor Rosenstone is
4	recommending an interim president until such time as a permanent president begins service.

6	Chancellor's Review Process
7	Nominations and expressions of interest were sought from the board, presidents, system office
8	staff and other individuals within and outside the system. Candidates were reviewed for
9	qualifications and a selection was made. Chancellor Steven Rosenstone is recommending
10	Connie J. Gores, Ph.D., to serve as interim president.

12	RECOMMENDED COMMITTEE ACTION
13	The Human Resources Committee recommends that the Board of Trustees adopts the following
14	motion.

17	The Board of Trustees, upon the recommendation of Chancellor Rosenstone, appoints Connie J.
18	Gores, Ph.D., as interim president of Winona State University effective May 17, 2012, subject to
19	the completion of an employment agreement. The Board authorizes the Chancellor, in
20	consultation with the Chair of the Board and Chair of the Human Resources Committee, to
21	negotiate and execute an employment agreement in accordance with the terms and conditions of
22	the Personnel Plan for Minnesota State Colleges and Universities Administrators.

- Leadership in capital and revenue fund projects that include the new Integrated Wellness Complex and a new residence hall complex, the first new on-campus residence hall project in forty years. Vision for and leadership of the first WSU Academic Theme House, a residential house with the theme of environmental sustainability.
- Instituted AAC&U's Core Commitments initiative that emphasizes taking seriously the perspectives of others: recognizing and acting on the obligation to inform one's own judgment; and engaging diverse and competing perspectives as a resource for learning, citizenship, and work.

Increased undergraduate ethnic diversity from 18% to 32% of student body; increased student fee revenue by \$7 million. In addition, expanded the presence of degree-seeking international students from 24 to 47 countries, resulting in the College's rank of 7<sup>th</sup> in the nation among national liberal arts colleges.
- Created a competitive honor scholarship program resulting in the strongest academic profile of new students in several decades. Increased all new student applications to highest on record.
- Partnered with non-profit educational and training organization to create an exemplary leadership training
  program for high school students and their teachers from Indonesia. Together we were successful in securing a
  multi-year grant totaling over \$1.5 million from the U.S. Department of State, Bureau of Educational and
  Cultural Affairs.

Successfully collaborated with faculty members on development of programs and curricula for pre-collegiate
courses, summer programs, and graduate programs in Education. Taught in inaugural interdisciplinary firstyear course. Closely involved with key faculty leaders from several departments in the formation of a campuswide Forum designed to explore topics and discuss planning for the future.
