

Updates to Perkins Eligibility and Gender Equity Designations: Overview

July 31, 2019

In summer 2017, a group of Minnesota State Research, Perkins, and Academic Program staff met to review and recommend updates to Perkins-eligibility, CTE pathway and gender equity designations for the over 1,700 existing CIP Codes with the intent to implement the changes in Perkins IV. The review was prompted by updates to a CIP Code/nontraditional designation crosswalk maintained by the National Alliance for Partnerships in Equity (NAPE) along with internal recognition of the need to review and update some of the Perkins-eligibility and pathway designations to be more consistent with national recommendations and/or state determination.

In all, the recommendations included:

- **9** updates to Perkins eligibility designations,
- **65** updates to CTE Pathways, and
- **780** updates to gender equity designations (with approximately 160 being meaningful changes and the remaining updating the gender equity designation to null for CIP Codes that are not Perkins eligible).

Note that not all of the CIP Codes are currently used/attached to system college academic programs or courses, but the review included all CIP Codes.

In reviewing the impact of the updates to Perkins-eligibility and, in particular, gender equity designations on Perkins IV accountability indicators, a decision was made to defer the updates until the Perkins legislation was reauthorized. Now that the ***Strengthening Career and Technical Education for the 21st Century Act*** passed and new postsecondary accountability measures, baseline data, and performance levels will be established, the recommended updates have been made in the related CIP Code table.

To assist consortia, we created a list of currently active academic programs at system colleges that **have an update to Perkins-eligibility or gender equity designations**. A full list of all of your current academic programs, complete with Perkins-eligibility, gender equity and pathway designations, can be found in the system's academic program inventory tool.
