## OPPORTUNITY OVERVIEW, *CONTINUED*

### COMMUNITY PARTNERSHIP AND REGIONAL IMPACT

St. Cloud State University is deeply rooted in Central Minnesota, with strong opportunities to serve the region's workforce and economic development while embracing a broader, global perspective. SCSU is seeking a president who will champion partnerships with local industries, technical and community colleges, and civic organizations to create clear pathways from education to employment. The university's location in St. Cloud and proximity to the Twin Cities offers the best of both worlds: close-knit community connections alongside metropolitan access. The president's leadership should deepen engagement, strengthen the institution's role as a regional convener, and ensure graduates are prepared to contribute to the economic and cultural vitality of Central Minnesota and beyond.

### STUDENT-CENTERED MISSION AND EXPERIENCE

SCSU has a proud tradition of access and excellence, serving many first-generation and historically marginalized students. The university serves as an engine for social mobility through its commitment to meeting students where they are, whether they are traditional undergraduates, international students, adult learners, or online students. The next president will work collaboratively across the university to strengthen the sense of belonging, broaden student experiences beyond the classroom, and ensure holistic support for student well-being. Leveraging the university's strengths in excellent teaching, hands-on learning, and strong job placement, the new president will increase philanthropic support, enhance retention, strengthen academic programs, and expand co-curricular and career development opportunities.

### REPUTATION, PRIDE, AND STORY-TELLING

The next president will be the chief advocate and champion for the university and will fortify SCSU's reputation and pride in the institution. The community will welcome a leader who will celebrate SCSU's achievements and tell its story compellingly. The president should be visible, vocal, and able to articulate and implement a clear vision for the future. With over 130,000 alumni worldwide and strong local support, there is untapped potential to engage a vast network of support for the university.

### VISIONARY AND COLLABORATIVE LEADERSHIP

SCSU is at a critical inflection point that requires a courageous leader with the ability to build consensus for difficult decisions. The president should be a servant leader who listens to all voices, respects shared governance, and builds trust among faculty, staff, students, alumni, and the broader community. The president must bring operational realism and a clear strategic vision that differentiates SCSU, aligns resources with priorities, strengthens morale, and positions SCSU to thrive in a changing higher education landscape. A successful leader will embrace both innovation and tradition, ensuring the university's identity is clear, relevant, and forward-looking.

### FISCAL SUSTAINABILITY AND STRATEGIC GROWTH

Budget challenges are a reality, which will require difficult decisions, but at the same time there are opportunities to diversify revenue streams and grow enrollment through targeted recruitment and program development. The next president should be adept at fundraising, cultivating major gifts, and leveraging partnerships to bring new resources to the university. The president should focus on high-demand academic areas, building on SCSU's strengths, and aligning offerings with workforce and community needs. With a sound financial strategy, the university can invest in revitalizing its riverfront campus, enhancing facilities, and supporting the programs that make SCSU a destination for students in Minnesota and beyond.

## ST. CLOUD STATE UNIVERSITY

St. Cloud State University has a rich history of serving the people of Minnesota. The University began in 1869 as the Third State Normal School, created for the sole purpose of educating primary school teachers to teach in Minnesota's schools.

Since the founding of St. Cloud State, the mission has evolved as the needs of the state and region changed, from offering a junior college curriculum in 1898, to a Teacher's College in 1921, to a university in 1975. The University began operating its Alnwick, England location in 1986 and Twin Cities location in 2007, the same year applied doctorate degrees were first offered. The main campus sits on 100 acres between downtown St. Cloud and the banks of the Mississippi River, and St. Cloud is 20th on Forbes magazine's "Best Small Places for Businesses and Careers."

SCSU is part of the Minnesota State system, which is the largest single provider of higher education in the state with 33 institutions, including seven state universities and 26 community and technical colleges. The University is proud of the partnerships and close relationships with the city of St. Cloud, educational entities and business, health and science industries in Central Minnesota and the Twin Cities. Minnesota is ranked as the No. 2 state for economic opportunity.

Serving more than 10,000 students, SCSU is one of the largest and diverse public universities in Minnesota. Students come from all across the United States and over 80 different countries, and SCSU has a network of over 134,000 alumni around the globe. SCSU offers nearly 100 in-demand undergraduate and graduate degree and certificate programs, and students have over 30 education abroad opportunities on six continents.

The University focuses on education that goes beyond the classroom, and this theory is emphasized in "Our Husky Compact," a promise the University makes to its students that they will be prepared as global citizens of the 21st Century as they participate in applied learning opportunities and real-world experiences in their field of study.

### FACILITIES PLAN

St. Cloud State University has revealed an ambitious new plan to create a more vibrant, connected campus environment.

The new plan calls for the removal of several of the older buildings on campus that are currently vacant, closed or underutilized to allow for more green space, creating a park-like environment in the heart of campus over the next few years.

SCSU maintains more square feet of buildings per student than any other Minnesota State institution, highlighting the need to occupy less space while enhancing the campus experience through the pedestrian walkways and increased natural spaces.

## COMMUNITY ENGAGEMENT

### A CORNERSTONE OF COMMUNITY AND ECONOMIC VITALITY

Since 1869, St. Cloud State University has been a driving force in Central Minnesota—serving as both a community cornerstone and an economic engine. Deeply embedded in the region's development, SCSU fosters meaningful partnerships with local nonprofits, government agencies, and industry leaders to address shared challenges and create lasting impact. The university is an active member of key civic organizations, including the Greater St. Cloud Development Corporation, the Rotary Club of St. Cloud, and the St. Cloud Area Chamber of Commerce.

As an anchor institution, SCSU plays a vital role in shaping the region's

workforce and economy. More than 30% of recent graduates choose to live and work within a 50-mile radius of St. Cloud, contributing their talents as educators, healthcare professionals, business leaders, and technology experts. The university's alumni generate an estimated **\$2.1 billion in annual economic impact** across Minnesota, supporting over **11,000 jobs** statewide.

Locally, SCSU contributes **\$598.8 million in annual economic impact**, sustaining more than **4,300 jobs** through university operations, capital projects, and student and visitor spending. These activities generate **\$42.8 million in tax revenue**, reinforcing the university's role as a catalyst for regional prosperity. With

a diverse academic portfolio and a global student body, SCSU continues to infuse energy, innovation, and opportunity into the Greater St. Cloud community.

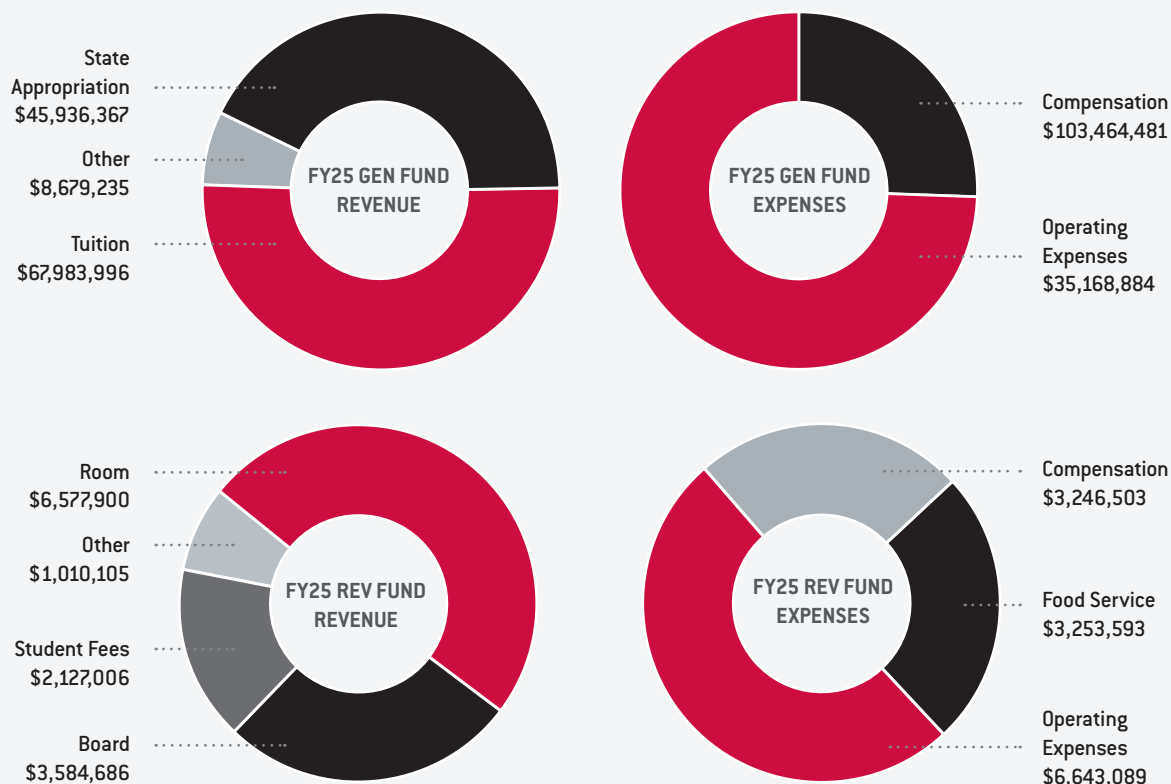

## FINANCIALS



### ST. CLOUD STATE UNIVERSITY FOUNDATION

The St. Cloud State University Foundation was established in 1958 as a 501(c)(3) not-for-profit organization to provide a means for alumni, friends, foundations and corporations to make tax-deductible contributions in support of the university. The Foundation exists to support and enhance St. Cloud State University's ability to ignite students' learning and discovery of their gifts, their passions, and their potential contributions to society. It serves as a leading source of external support for the University.

The Foundation is governed by a board made up of professionals who share a commitment to St. Cloud State University and a willingness to invest their time, talent and treasure for the betterment of the University through fundraising and advocacy.

In the academic year 2025-2026, the SCSU Foundation will fund over 1000 scholarships for a total of almost \$1.7M. In addition, the Foundation provides crucial funds to the University to enhance strategic initiatives such as removing barriers to education, providing robust individualized student support, facilitating academic success and innovation, creating dynamic living and learning spaces and fostering a vibrant campus life and athletics experience. The SCSU Foundation currently manages an endowment portfolio of \$56M and assets totaling nearly \$60M.



## MINNESOTA STATE

At Minnesota State we provide the opportunity for all Minnesotans to create a better future for themselves, for their families, and for their communities.

With 26 community and technical colleges and seven state universities on 54 campuses, Minnesota State serves nearly two-thirds of the entire state's undergraduate student population, and we serve more Black, Indigenous, and students of color than all higher education providers in the state, combined.

We are committed to equitable outcomes for all our students, and in 2019 committed to eliminating educational equity gaps at every Minnesota State college and university by the year 2030. Achieving this goal, called Equity 2030, is a moral imperative, and an economic imperative for our state as our population continues to grow more diverse, and will ensure Minnesota has the workforce it needs for generations to come. We are working toward meeting our Equity 2030 goal through hard work, robust data analysis, targeted programs to improve outcomes, and partnerships with community organizations, employers, and the state legislature.
