



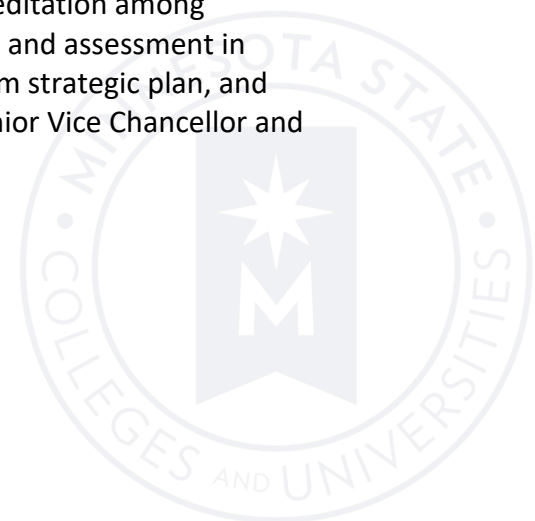

Job Summary:

This position oversees the accreditation support services and administers system-wide policies by working with the campus Accreditation Liaison Officers (ALO) to achieve successful accreditation and reaffirmation of accreditation. As a member of the Academic Programs and Quality Assurance unit, the incumbent for this position provides leadership and management for the development and implementation of Minnesota State policies and procedures for accreditation and assessment; represents system accreditation and assessment interests to a wide variety of constituent groups; fosters national and regional accreditation among Minnesota State colleges and universities; and manages accreditation and assessment in response to legislation, policy, college and university needs, the system strategic plan, and direction from the Associate Vice Chancellor for Academic Affairs, Senior Vice Chancellor and Board of Trustees.
